The Public Sector Standard Conditions of Contract for Construction Works, commonly known as the PSSCOC, is a frequently encountered standard form building contract in Singapore. Many public sector projects will frequently incorporate the PSSCOC, or a modification of the PSSCOC, as part of the relevant contractual conditions. As such, it is important for contract administrators to be familiar with the key provisions in the PSSCOC when administering the contract.

In this short half-day session, we will go through some of the key provisions in the 2020th Edition of the PSSCOC, covering areas the role of the Superintending Officer, the provisions governing liquidated damages and extensions of time, how variations can be ordered and valued, as well as provisions relating to termination (both by the employer and the contractor).

The objective of this session is to let attendees have a basic working knowledge of some of the key clauses in the PSSCOC.
